A. BASIC TERMS

4.	Brief Description of Contest/ Programme	This is an on-ground contest to giveaway Huawei Nova 4 mobile phone.
5.	Brief mechanism of Contest	<p>Contestants must register online at www.hitz.com.my ("Online Registration") or authorised Huawei Stores situated at Sunway Pyramid or Pavilion KL depending on the Contest date ("On Ground Registration") to participate in this Contest, based on the Entry Procedure below.</p> <p>Both Online Registration and On Ground Registration Contestants will need to be present at the specific Huawei authorised outlet in the location specified below on the selected Contest date by 12pm. The Contest will be held on the following date, time and location:</p> <ol style="list-style-type: none"> 1. 14th February 2019 (12pm to 1pm) – Sunway Pyramid 2. 2nd March 2019 (12pm to 1pm) – Pavilion KL <p>The registered Contestant needs to share an entrance post on his/her personal Facebook account with the specified caption posted on "Huawei Mobile MY" Facebook page before beginning the search and show the proof to the Organiser or the authorised representatives in the authorised Huawei Stores.
