Brief Description of Competition	<p>This is a talent search competition to search for multi-talented MC who are capable of hosting on-air program, on ground event as well as being a social media influencer.</p> <p>Tag along with social media contests that would need to answer a simple question regarding to GOXUAN The Rising's video episodes each week at GOXUAN Instagram post for a chance to win RM150 cash prize and food vouchers sponsor by Monster Chef</p> <p>Besides Logon to goxuan.my to vote for your favorite contestants and this will be affecting their scores in different episodes. Elimination will happen on certain round of challenge. Decision of elimination will be made by a panel of judges selected by the Organizer and/or other selection criteria as determined by the Organizer from times to times.</p>
5.	Brief mechanism of Competition	<p>The contest will be promoted on-air, online and on social media.</p> <p>(a) GOXUAN The Rising MC Search</p> <p>To participate in the competition, the contestants will be required to register on goxuan.my and submit a YouTube link of a 1-minute video introducing themselves in the most creative way. Contestants are required to set their YouTube account as public for organizer checking purpose.</p> <p>Top 12 finalist will be selecting through 2 weeks of online recruitment. The finalists would require going through a series of challenges around 4 weeks, which include hosting on-ground activity, making a vlog, hosting a recorded video program on-camera and hosting a radio program on-air. GOXUAN MC will be the coach of the candidates.</p> <p>All the challenges will be pre-recorded in video and will be posted on goxuan.my, GOXUAN Facebook and GOXUAN YouTube channel. Audiences and listeners are allowing to answer a simple question relating to each episode to win away RM150 cash prize and food voucher sponsored by Monster Chef.</p> <p>Logon to goxuan.my to vote for your favorite contestants and this will be affecting their scores in different episodes. Elimination will happen on certain round of challenge. Decision of elimination will be made by a panel of judges selected by the Organizer and/or other selection criteria as determined by the Organizer from times to times.</p> <p>In order to qualify to take part in this competition, the contestants have to make themselves available throughout the shooting dates, which include 30 March, 2, 3, 5, 6, 12, 27 April 2019 at the designated shooting venue in Klang Valley/Kuala Lumpur.</p>

Winner announcements will be made on air every day after contest.</p> <p>A Contestant is allowed to submit one (1) entry in this Contest only. Duplicate or subsequent entry(ies) will be disqualified.</p> <p>The Contestants must adhere to the mechanism of the Competition as may be briefed and communicated to the Contestants by the Organiser during the Competition Period.</p>

The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Competition.
