



## Hitz Emoji Hit with Lazada's 7th Bday Celebration TERMS AND CONDITIONS

**NOTE: This Terms and Conditions is attached to and supplement the Terms and Conditions of Hitz Emoji Hit V2. This Terms and Conditions is to set out the additional Prize given out for the Contest in conjunction with Lazada's 7<sup>th</sup> Bday Celebration, during the Contest Period set out below.**

### A. BASIC TERMS

1.	<b>Organiser</b>	ASTRO RADIO SDN BHD
2.	<b>Radio Station</b>	hitz
3.	<b>Name of Contest</b>	Hitz Emoji Hit with Lazada's 7th Bday Celebration
4.	<b>Brief Description of Contest/ Programme</b>	This is a call-in contest to name the song title based on the Emoji clue posted on the hitz Instagram account to win a minimum cash prize of RM 100 (based on the Contest, Hitz Emoji Hit V2) and an additional prize of Lazada Wallet top-up amount with a minimum value of RM 100.
5.	<b>Brief mechanism of Contest</b>	<p>Be the first caller through after the cue to call and name the song title based on the Emoji clue posted on the hitz Instagram account for that hour. Each contest segment will have a minimum cash prize of RM 100 (based on the Contest, Hitz Emoji Hit V2) and an additional prize of Lazada Wallet top-up amount of RM 100. If the answer is incorrect, the Contestant will not win any prize and the cash prize (based on the Contest, Hitz Emoji Hit V2) along with the Lazada Wallet top-up value will be snowballed to the next contest segment.</p> <p><b><u>Bonus Round</u></b></p> <p>There will be bonus round(s) where the Lazada Wallet top-up amount for that contest segment (exclusive of the snowballed Lazada Wallet top-up amount accumulated from the previous contest segment(s)) will be doubled up to RM200.</p> <p>The Emoji clue posted on the hitz Instagram account will not be reused for the next contest segment.</p> <p>The Contestants must adhere to the mechanism of the Contest as may be changed, amended, notified or communicated by the Organiser during the Contest Period.</p>
6.	<b>Eligibility Criteria</b>	<p>a) The Contest is open to all Malaysians of the Age of Eligibility below.</p> <p>b) Contestants must be Malaysian citizens and must possess valid Malaysian Identity Cards.</p>
7.	<b>Ineligibility</b>	<p>The following persons are not eligible to participate in the Contest :-</p> <p>(a) Employees/vendors/contractors and their *immediate family members of the Organiser, MEASAT Broadcast Network Systems Sdn Bhd, Astro Entertainment Sdn Bhd, Astro Production Sdn Bhd, Astro Digital 5 Sdn Bhd and Astro Malaysia Holdings Berhad, the sponsor of the Contest and their affiliates and partners.</p> <p>(b) Has won any prize(s) up to a value either individually or collectively of a value of RM1,000 and below from the Radio Station in the period of thirty (30) days prior to entering the Contest.</p>

		<p>(c) Has won any prize(s) up to a value either individually or collectively of a value of RM1,001 to RM5,000 from the Radio Station in the period of ninety (90) days prior to entering the Contest.</p> <p>(d) Has won any prize(s) up to a value either individually or collectively of a value of RM5,001 and above from the Radio Station in the period of three hundred and sixty-five (365) days prior to entering the Contest.</p> <p>*immediate family members mean spouse, children, parents, brothers and sisters</p>
8.	<b>Age of Eligibility</b>	<p>a) The Contest is open to all Malaysians who are 12 years old and above as at 21<sup>st</sup> March 2019.</p> <p>b) Where the Age of Eligibility permits participation of Contestants under the age of 18 years old, the Contestant must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in the Contest and to receive the Prize. The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest. The parents and/or guardian may at the absolute discretion of the Organiser be required to sign an indemnity in the form required by the Organiser as a precondition to their child's entitlement to the Prize.</p>
9.	<b>Charges</b>	Standard charges charged by the Contestant's relevant telecommunications service provider applies.
10.	<b>Contest Period</b>	<p>21<sup>st</sup> March – 27<sup>th</sup> March 2019.</p> <p>The Organiser reserves the right to vary, extend, postpone or re-schedule the Contest Period or any dates thereof at its sole discretion.</p>

12.	<b>Entry Procedure</b>	The Contestant must be the first caller through after the cue to call.
13.	<b>Entry Deadline</b>	27 <sup>th</sup> March 2019.
14.	<b>Mode</b>	Call-In – By calling Radio Station's telephone number - 03 9543 3311
15.	<b>Address</b>	<p>All Asia Broadcast Centre          Malaysia Technology Park          Bukit Jalil          57000 Kuala Lumpur Malaysia</p>
16.	<b>Selection of winners</b>	The first caller through after the cue to call and identified the song title correctly based on the Emoji posted on the hitz Instagram account for that hour.
17.	<b>Prize</b>	<p>A minimum cash prize of RM 100 &amp; Lazada Wallet top-up amount of RM 100, depending on the snowballed amount.</p> <p><b><u>Bonus Round</u></b>          A minimum cash prize of RM 100 &amp; Lazada Wallet worth a minimum of RM 200, depending on the snowballed amount. The snowballed amount will not be doubled up for the Bonus Round.</p>
18.	<b>Notification of winners</b>	Winners will be notified right after the call-in Contest.
19.	<b>Collection Period</b>	Telegraphic Transfer to the winner's bank account within 1 month from notification by the Organiser
20.	<b>Collection Venue</b>	Not applicable
21.	<b>Additional Terms, if any</b>	To receive the Prize, the winner must activate his/her LAZADA Wallet based on the instructions/steps provided by LAZADA and provide the registered email address, name (as per identity card) and mobile number of his/her LAZADA account. Any winner who failed to provide the required information

		<p>within the period specified by the Organiser will not receive the LAZADA Wallet top-up amount and the Organiser/LAZADA shall not be responsible to award the LAZADA Wallet top-up amount to such winner.</p> <p>In the event the telegraphic transfer transaction to the winner's bank account fails due to incomplete and/or wrong information provided by the winner, the Organiser reserves the right to deduct RM10.00 from the value of the Prize for each re-submission of such transaction.</p> <p>In the event the winner requires reissuance of cheque for the Prize, RM50.00 will be deducted from the value of the Prize unless such reissuance is due to the negligence, omission and/or fault of the Organiser.</p> <p><b>LINE DROP OUT AND INABILITY TO CONTACT***</b></p> <p><b>Telephone Contests</b> No liability is assumed by the Organiser for faulty, mistranscribed, misdirected/misdialled telephone communication or technical difficulties experienced by callers throughout the call-in portion of a Contest.</p> <p>If in the course of a Contest -</p> <ol style="list-style-type: none"> <li>a telephone line breaks up or drops out; or</li> <li>there is a dispute arising out of the use of telephone lines in a Contest (including situations where multiple telephone lines are used); or</li> <li>two telephone lines are crossed during a phone in Contest;</li> </ol> <p>the Organiser may in its absolute discretion disqualify the relevant caller or callers for any reason whatsoever, and shall not be responsible for awarding a Prize to the relevant caller or callers, and may award the Prize to another person, at its sole and absolute discretion.</p> <p>In the event that a voice other than the caller's (or Contestant's) is heard on the phone line, the qualifying Contestant or Winner will be the first person on the phone line to speak. If the judge(s) is not able to determine which caller was the first to speak on the phone line, a random drawing will be held to determine the Winner, and the outcome of the draw will be final.</p> <p>Any entries which are found to have used telephone switching or programming equipment shall be disqualified.</p> <p>In telephone Contests, "sonic triggers" are effective only when heard on on-air radio broadcast, and internet streaming shall not be valid as there may be delays in audio transmission or errors on the internet</p> <p>All Prizes won are strictly non-transferable to another party and cannot be exchanged or re-sold in any manner whatsoever for any other item, prize or cash.</p> <p>The panel of judges (if applicable) will be determined at the sole discretion of the Organiser and/or the sponsor. The Organiser may in its absolute discretion disqualify any Contestants for any reason whatsoever, and any decisions by the judges, Organiser and/or the sponsor relating to the Contest shall be final and the Organiser and/or the sponsor will not entertain any appeals by the Contestants against the decision.</p> <p>If the Prizes awarded by the Organiser are in the form of free tickets or passes:</p> <ol style="list-style-type: none"> <li>the winner shall be bound by the event promoter's or sponsor's terms and conditions;</li> <li>the winner must adhere to those terms and conditions set out on the ticket (such as film classification) and the rules and regulations of the venue thereof; and</li> <li>the venue, date and time of the event/programme/movie/show may be changed at any time at the absolute discretion of the Organiser, event promoter or sponsor.</li> </ol>
