4.	Brief Description of Contest/ Programme	This is an online contest to win exclusive prizes from hitz.

Brief mechanism of Contest	<ol style="list-style-type: none"> Log on to www.hitz.my Contestants are required to: <ul style="list-style-type: none"> -submit a screenshot of their authentic Covid-19 Vaccination Digital Certificate from their MySejahtera application which must show that the Contestants have received two (2) doses of the vaccine; -correctly answer a question; and -complete a slogan (in not more than 25 words). <p>The Organiser reserves the right to automatically disqualify the Contestant if the screenshot is found to be doctored and/or not authentic.</p> Winners shall be selected at the sole discretion of the Organiser. Each winner shall receive a call from the announcers. During the call, the winner shall be asked to pick a number (out of 1 – 20) from the hitz whiteboard in the studio. The type of prize the winner wins shall be according to the number they have picked. The process of picking the prize by the winner will be broadcast on Instagram live on the hitz Instagram official account. <p>A Contestant may submit multiple entries in this Contest. However, a Contestant can only win once in this Contest.
