



## HITZ-DLE 2022 with New York Skin Solutions TERMS AND CONDITIONS

### A. BASIC TERMS

1.	<b>Organiser</b>	ASTRO RADIO SDN BHD (COMPANY NO. 199601031120 (403472-D))
2.	<b>Radio Station</b>	HITZ FM
3.	<b>Name of Contest</b>	HITZ-DLE 2022 with New York Skin Solutions.
4.	<b>Brief Description of Contest/ Programme</b>	This is a call-in contest for a chance to win cash prizes.
5.	<b>Brief mechanism of Contest</b>	<ol style="list-style-type: none"> <li>1. Each Contesting hour, an Instagram story will be posted on the Hitz official Instagram account which will be a puzzle of a song title.</li> <li>2. Be the first caller through after the cue to call.</li> <li>3. The announcer will play a one (1) second clip of the song and the Contestant will need to choose between: <ol style="list-style-type: none"> <li>(i) guessing a letter contained in the song title to win RM100 cash (if Bonus Round: RM200 cash); or</li> <li>(ii) guessing the entire / full song title to win RM500 cash (if Bonus Round: RM1,000 cash).</li> </ol> </li> <li>4. If the Contestant does not guess correctly, they will not win anything.</li> <li>5. There shall be no snowball of the cash prize.</li> </ol> <p>The Contestants must adhere to the mechanism of the Contest as may be changed, amended, notified or communicated by the Organiser during the Contest Period.</p>
6.	<b>Eligibility Criteria</b>	<ol style="list-style-type: none"> <li>a) The Contest is open to all Malaysians of the Age of Eligibility below.</li> <li>b) Contestants must be Malaysian citizens and must possess valid Malaysian Identity Cards.</li> </ol>
7.	<b>Ineligibility</b>	<p>The following persons are not eligible to participate in the Contest :-</p> <ol style="list-style-type: none"> <li>(a) Employees/vendors/contractors and their *immediate family members of the Organiser, MEASAT Broadcast Network Systems Sdn Bhd, Astro Entertainment Sdn Bhd, Astro Production Sdn Bhd, Astro Digital 5 Sdn Bhd and Astro Malaysia Holdings Berhad, the sponsor of the Contest and their affiliates and partners.</li> <li>(b) Has won any prize(s) up to a value either individually or collectively of a value of RM1,000 and below from the Radio Station in the period of thirty (30) days prior to entering the Contest.</li> <li>(c) Has won any prize(s) up to a value either individually or collectively of a value of RM1,001 to RM5,000 from the Radio Station in the period of ninety (90) days prior to entering the Contest.</li> <li>(d) Has won any prize(s) up to a value either individually or collectively of a value of RM5,001 and above from the Radio Station in the period of three hundred and sixty-five (365) days prior to entering the Contest.</li> </ol>

8.	<b>Age of Eligibility</b>	<p>a) The Contest is open to all Malaysians who are 13 years old and above at the time of submission of entry or as at the date of participation in the Contest.</p> <p>b) Where the Age of Eligibility permits participation of Contestants under the age of 18 years old, the Contestant must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in the Contest and to receive the Prize. The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest. The parents and/or guardian may at the absolute discretion of the Organiser be required to sign an indemnity in the form required by the Organiser as a precondition to their child's entitlement to the Prize.</p>

10.	<b>Contest Period</b>	<p>19 September 2022 - 7 October 2022</p> <p>The Organiser reserves the right to vary, extend, postpone or re-schedule the Contest Period or any dates thereof at its sole discretion.</p>
11.	<b>Language of Contest</b>	English
12.	<b>Entry Procedure</b>	The Contestant must be the first caller through after the cue to call.

16.	<b>Selection of winners</b>	The first caller through after the cue to call, who correctly guesses either a letter contained in the song title or the entire / full song title, based on the song clip played.
17.	<b>Prize</b>	<p>Each winner shall receive:</p> <ul style="list-style-type: none"> <li>- correctly guesses a letter contained in the song title = RM100 cash (if Bonus Round: RM200 cash)</li> <li>or</li> <li>- correctly guesses the entire / full song title = RM500 cash (if Bonus Round: RM1,000 cash)</li> </ul> <p>For the avoidance of doubt, the prizes are given on an 'either or' basis and not a cumulative basis i.e. if winner guesses the entire / full song title, prize shall be RM500 cash and not RM600 cash (if Bonus Round: prize shall be RM1,000 cash and not RM1,200 cash).</p>

The winner must provide accurate bank account or transfer details to the Organiser. In the event the telegraphic transfer transaction to the winner's bank account fails due to incomplete</p>

The winner shall be responsible for all charges related to the issuance, re-issuance and/or clearance of the cheque. Such charges shall be deducted from the value of the cash prize, unless such charges are incurred due to the negligence, omission and/or fault of the Organiser.</p> <p><b>LINE DROP OUT AND INABILITY TO CONTACT***</b></p> <p><b>Telephone Contests</b> No liability is assumed by the Organiser for faulty, mistranscribed, misdirected/misdialled telephone communication or technical difficulties experienced by callers throughout the call-in portion of a Contest.</p> <p>If in the course of a Contest -</p> <ol style="list-style-type: none"> <li>a) a telephone line breaks up or drops out; or</li> <li>b) there is a dispute arising out of the use of telephone lines in a Contest (including situations where multiple telephone lines are used); or</li> <li>c) two telephone lines are crossed during a phone in Contest;</li> </ol> <p>the Organiser may in its absolute discretion disqualify the relevant caller or callers for any reason whatsoever, and shall not be responsible for awarding a Prize to the relevant caller or callers, and may award the Prize to another person, at its sole and absolute discretion.</p> <p>In the event that a voice other than the caller's (or Contestant's) is heard on the phone line, the qualifying Contestant or Winner will be the first person on the phone line to speak. If the judge(s) is not able to determine which caller was the first to speak on the phone line, a random drawing will be held to determine the Winner, and the outcome of the draw will be final.</p> <p>Any entries which are found to have used telephone switching or programming equipment shall be disqualified.</p> <p>In telephone Contests, "sonic triggers" are effective only when heard on on-air radio broadcast, and internet streaming shall not be valid as there may be delays in audio transmission or errors on the internet</p> <p>All Prizes won are strictly non-transferable to another party and cannot be exchanged or re-sold in any manner whatsoever for any other item, prize or cash.</p> <p>The panel of judges (if applicable) will be determined at the sole discretion of the Organiser and/or the sponsor. The Organiser may in its absolute discretion disqualify any Contestants for any reason whatsoever, and any decisions by the judges, Organiser and/or the sponsor relating to the Contest shall be final and the Organiser and/or the sponsor will not entertain any appeals by the Contestants against the decision.</p> <p>If the Prizes awarded by the Organiser are in the form of free tickets, passes or vouchers:</p> <ol style="list-style-type: none"> <li>(a) the winner shall be bound by the event promoter's, sponsor's or issuer's terms and conditions;</li> <li>(b) the winner must adhere to those terms and conditions set out on the ticket, pass or voucher (such as film classification) and the rules and regulations of the venue thereof; and</li> <li>(c) the venue, date and time of the event/programme/movie/show may be changed at any time at the absolute discretion of the Organiser, event promoter and/or sponsor.</li> </ol>
