



## Read Between The Lines on Lite TERMS AND CONDITIONS

### A. BASIC TERMS

1.	<b>Organiser</b>	ASTRO RADIO SDN BHD (COMPANY NO. 199601031120 (403472-D))
2.	<b>Radio Station</b>	Litefm
3.	<b>Name of Contest</b>	Read Between The Lines
4.	<b>Brief Description of Contest/ Programme</b>	This is an on-ground contest for a chance to win a cash prize.
5.	<b>Brief mechanism of Contest</b>	<p>During each Contesting week:</p> <ol style="list-style-type: none"> <li>1. Contestants must listen to Litefm from Monday to Wednesday for the clues which will be given out every hour from 9am till 5pm, each day.</li> <li>2. All the clues will be in a form of song lyrics.</li> <li>3. Contestants must use the lyrics to decipher where Litefm's crew-on-duty will be at, on Thursday, at 7am - 8am.</li> <li>4. There will be a password that the Contestants will need to retrieve from the SYOK mobile application, on Wednesday at 1pm onwards.</li> <li>5. The first Contestant that arrives at the correct location on Thursday during the 7am - 8 am timing, and provides the correct password will win the cash prize. In the event there are two or more Contestants, who arrive at the same time, then there shall be a tiebreaker.</li> <li>6. For the tiebreaker, Contestants have to provide the song title to the song lyrics given by the Litefm crew-on-duty. The Contestants shall be required to shout their name as the buzzer before they can answer and must provide their answer within five (5) seconds. The winner shall be the Contestant who gets / names two (2) song titles correctly. The winner of the tiebreaker shall win the cash prize.</li> </ol> <p>A Contestant may submit multiple entries in this Contest. However, a Contestant can only win once in this Contest. Any subsequent wins (if declared) will be automatically void.</p> <p>The Contestants must adhere to the mechanism of the Contest as may be changed, amended, notified or communicated by the Organiser during the Contest Period.</p>
6.	<b>Eligibility Criteria</b>	<ol style="list-style-type: none"> <li>a) The Contest is open to all Malaysians of the Age of Eligibility below.</li> <li>b) Contestants must be Malaysian citizens and must possess valid Malaysian Identity Cards.</li> </ol>
7.	<b>Ineligibility</b>	<p>The following persons are not eligible to participate in the Contest :-</p> <ol style="list-style-type: none"> <li>(a) Employees/vendors/contractors and their *immediate family members of the Organiser, MEASAT Broadcast Network Systems Sdn Bhd, Astro Entertainment Sdn Bhd, Astro Production Sdn Bhd, Astro Digital 5 Sdn Bhd and Astro Malaysia Holdings Berhad, the sponsor of the Contest and their affiliates and partners.</li> <li>(b) Has won any prize(s) up to a value either individually or collectively of a value of RM1,000 and below from the Radio Station in the period of thirty (30) days prior to entering the Contest.</li> </ol>

		<p>(c) Has won any prize(s) up to a value either individually or collectively of a value of RM1,001 to RM5,000 from the Radio Station in the period of ninety (90) days prior to entering the Contest.</p> <p>(d) Has won any prize(s) up to a value either individually or collectively of a value of RM5,001 and above from the Radio Station in the period of three hundred and sixty-five (365) days prior to entering the Contest.</p> <p>*immediate family members mean spouse, children, parents, brothers and sisters</p>
8.	<b>Age of Eligibility</b>	<p>a) The Contest is open to all Malaysians who are 18 years old and above at the time of submission of entry or as at the date of participation in the Contest.</p> <p>b) Where the Age of Eligibility permits participation of Contestants under the age of 18 years old, the Contestant must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in the Contest and to receive the Prize. The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest. The parents and/or guardian may at the absolute discretion of the Organiser be required to sign an indemnity in the form required by the Organiser as a precondition to their child's entitlement to the Prize.</p>

12.	<b>Entry Procedure</b>	<p>The Contestant must be present at the location where Litefm's crew-on-duty is at on Thursday (22 September 2022, 29 September 2022 and/or 6 October 2022) during the 7am - 8am timing. Entry is on a first come first serve basis.</p> <p>The Organiser shall be entitled to request to sight the original Identity Card or the originals of other supporting documents/materials for verification purposes.</p>
13.	<b>Entry Deadline</b>	The Contestant must be present at the correct location where Litefm's crew-on-duty is at on Thursday, (22 September 2022, 29 September 2022 and/or 6 October 2022) during the 7am - 8am timing.
14.	<b>Mode</b>	On Ground
15.	<b>Address</b>	All Asia Broadcast Centre, Technology Park Malaysia, Lebuhraya Puchong-Sungai Besi, Bukit Jalil, 57000 Kuala Lumpur
16.	<b>Selection of winners</b>	<p>The first Contestant who is present at the correct location where Litefm's crew-on-duty is at on Thursday, (22 September 2022, 29 September 2022 and/or 6 October 2022) during the 7am - 8am timing, and provides the correct password.</p> <p>If there is a tiebreaker which shall be run according to the procedure set out in the Brief mechanism, then the winner shall be the Contestant who in the Organiser's sole and absolute discretion has provided two (2) correct song titles, each to be provided within five (5) seconds.</p> <p>There shall be a maximum of only ONE (1) winner per location. For clarity, if no Contestant shows up during the 7am - 8am timing and/or the wrong password is provided, then there shall be no winner for that location and the Organiser reserves the right to not give out the cash prize for that location.</p>
17.	<b>Prize</b>	Each winner shall win a RM5,000 cash prize.
