4.	Brief Description of Contest/ Programme	This is an online contest for a chance to be selected as MELODY CHEFS 2024 and win cash prize
5.	Brief mechanism of Contest	<p>This Contest consist of three (3) stages:</p> <p>First Stage – Submission</p> <ol style="list-style-type: none"> 1. The Contestants are required to upload a photo of their dish based on their own cooking recipe on melody.syok.my 2. A Contestant is allowed to submit (1) entry in this Contest only. Duplicate or subsequent entry(ies) will be disqualified. 3. Six (6) Contestants will be shortlisted to participate in the Second and Third Stage. <p>Second Stage – Video Shooting</p> <ol style="list-style-type: none"> 1. Each shortlisted Contestants will be paired up with a MELODY announcer as decided by the Organiser in its absolute discretion. 2. The Contestants are then required to teach their respective announcers on how to cook the dishes submitted by the Contestants during the First Stage. <p>Third Stage – Finale (Facebook Live)</p> <ol style="list-style-type: none"> 1. MELODY announcers will cook the dish taught during the Second Stage with the assistance of the Contestants. 2. One (1) winner will be selected based on the Organiser, Radio Station and/or judges scoring in its absolute discretion. <p>The shortlisted Contestants shall take part in but not limited to station shoot, on air interview, Facebook Live and promotional activities in relation to this Contest. No allowance will be given to the Contestants during this period.</p> <p>The Contestants must adhere to the mechanism of the Contest as may be changed, amended, notified or communicated by the Organiser during the Contest Period.</p>
6.	Eligibility Criteria	<ol style="list-style-type: none"> a) The Contest is open to all Malaysians of the Age of Eligibility below. b) Contestants must be Malaysian citizens and must possess valid Malaysian Identity Cards.
7.	Ineligibility	<p>The following persons are not eligible to participate in the Contest :-</p> <ol style="list-style-type: none"> (a) Employees/vendors/contractors and their *immediate family members of the Organiser, MEASAT Broadcast Network Systems Sdn Bhd, Astro Entertainment Sdn Bhd, Astro Production Sdn Bhd, Astro Digital 5 Sdn Bhd and Astro Malaysia Holdings Berhad, the sponsor of the Contest and their affiliates and partners.

		<p>(b) Has won any prize(s) up to a value either individually or collectively of a value of RM1,000 and below from the Radio Station in the period of thirty (30) days prior to entering the Contest.</p> <p>(c) Has won any prize(s) up to a value either individually or collectively of a value of RM1,001 to RM5,000 from the Radio Station in the period of ninety (90) days prior to entering the Contest.</p> <p>(d) Has won any prize(s) up to a value either individually or collectively of a value of RM5,001 and above from the Radio Station in the period of three hundred and sixty-five (365) days prior to entering the Contest.</p> <p>*immediate family members mean spouse, children, parents, brothers and sisters</p>

Age of Eligibility	<p>a) The Contest is open to all Malaysians who are 18 years old and above at the time of submission of entry or as at the date of participation in the Contest.</p> <p>b) Where the Age of Eligibility permits participation of Contestants under the age of 18 years old, the Contestant must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in the Contest and to receive the Prize. The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest. The parents and/or guardian may at the absolute discretion of the Organiser be required to sign an indemnity in the form required by the Organiser as a precondition to their child's entitlement to the Prize.</p>

Entry Procedure	<p>First Stage (Submission) : The Contestants are required to upload a photo of their dish based on their own cooking recipe and fill up their personal information on melody.syok.my.</p> <p>Second Stage (Video Shooting) & Third Stage (Finale): The shortlisted Contestants shall be available and be present at such location(s) as the Organiser may notify the Contestants throughout the Contest Period, failing which the Contestants may be disqualified and the Organiser has the absolute right to select other Contestants to replace such disqualified Contestants. The Organiser shall be entitled to request to sight the original identity card of the Contestant or other supporting documents/materials for verification purposes</p>
