



## BEAT THE MUSIC ON MIX TERMS AND CONDITIONS

### A. BASIC TERMS

1.	<b>Organiser</b>	ASTRO RADIO SDN BHD
2.	<b>Radio Station</b>	MIX
3.	<b>Name of Contest</b>	BEAT THE MUSIC ON MIX
4.	<b>Brief Description of Contest/ Programme</b>	This is a call-in contest for a chance to win Money.
5.	<b>Brief mechanism of Contest</b>	<ol style="list-style-type: none"> <li>1. Be the first caller through after the cue to call;</li> <li>2. An audio snippet of a song will be played will be played (maximum duration 5 seconds). As the audio snippet plays there will be a countdown starting at RM 100 and counting down in decrements of 25 Malaysian Ringgit per second. A buzzer will sound at the end of the 5 second snippet</li> <li>3. The Contestant will have five seconds when the audio snippet is played to shout 'Stop' and then identify the title and name of the singer of the song played.</li> <li>4. If the title and singer name given are correct, the Contestant wins the Prize based on the following:- <ul style="list-style-type: none"> <li>• If the Contestant yelled stop within 1 second they will win RM 100</li> <li>• If the Contestant yelled stop after 3 seconds they will win RM 50</li> <li>• If the Contestant yelled stop after 4 seconds they will win RM 25</li> <li>• If the Contestant yelled stop after 5 seconds ( when the buzzer sounds) they win nothing</li> </ul> </li> </ol> <p>The Contestants must adhere to the mechanism of the Contest as may be changed, amended, notified or communicated by the Organiser during the Contest Period.</p>
6.	<b>Eligibility Criteria</b>	<ol style="list-style-type: none"> <li>a) The Contest is open to all Malaysians of the Age of Eligibility below.</li> <li>b) Contestants must be Malaysian citizens and must possess valid Malaysian Identity Cards.</li> </ol>
7.	<b>Ineligibility</b>	<p>The following persons are not eligible to participate in the Contest :-</p> <ol style="list-style-type: none"> <li>(a) Employees/vendors/contractors and their *immediate family members of the Organiser, MEASAT Broadcast Network Systems Sdn Bhd, Astro Entertainment Sdn Bhd, Astro Production Sdn Bhd, Astro Digital 5 Sdn Bhd and Astro Malaysia Holdings Berhad, the sponsor of the Contest and their affiliates and partners.</li> <li>(b) Has won any prize(s) up to a value either individually or collectively of a value of RM1,000 and below from the Radio Station in the period of thirty (30) days prior to entering the Contest.</li> <li>(c) Has won any prize(s) up to a value either individually or collectively of a value of RM1,001 to RM5,000 from the Radio Station in the period of ninety (90) days prior to entering the Contest.</li> <li>(d) Has won any prize(s) up to a value either individually or collectively of a value of RM5,001 and above from the Radio Station in the period of three hundred and sixty-five (365) days prior to entering the Contest.</li> </ol>

8.	<b>Age of Eligibility</b>	<p>a) The Contest is open to all Malaysians who are 18 years old and above as at 2<sup>nd</sup> of September 2019.</p> <p>b) Where the Age of Eligibility permits participation of Contestants under the age of 18 years old, the Contestant must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in the Contest and to receive the Prize. The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest. The parents and/or guardian may at the absolute discretion of the Organiser be required to sign an indemnity in the form required by the Organiser as a precondition to their child's entitlement to the Prize.</p>

16.	<b>Selection of winners</b>	<p><b><u>Cash Prize</u></b></p> <p>the first caller through after the cue to call, stop the audio snippet played within 5 seconds and identified the song title and name of singer correctly.</p>
17.	<b>Prize</b>	<p><b><u>Cash Prize</u></b></p> <p>Up to RM100 per winner, depending on when the Contestant yelled stop, the amount is as set out in Brief mechanism of Contest above.</p>
18.	<b>Notification of winners</b>	Winners will be notified right after the call-in Contest.

21.	<b>Additional Terms, if any</b>	<p>In the event the telegraphic transfer transaction to the winner's bank account fails due to incomplete and/or wrong information provided by the winner, the Organiser reserves the right to deduct RM10.00 from the value of the Prize for each re-submission of such transaction.</p> <p>In the event the winner requires reissuance of cheque for the Prize, RM50.00 will be deducted from the value of the Prize unless such reissuance is due to the negligence, omission and/or fault of the Organiser.</p> <p>LINE DROP OUT AND INABILITY TO CONTACT***</p> <p>Telephone Contests</p>

		<p>No liability is assumed by the Organiser for faulty, mistranscribed, misdirected/misdialled telephone communication or technical difficulties experienced by callers throughout the call-in portion of a Contest.</p> <p>If in the course of a Contest -</p> <ul style="list-style-type: none"> <li>a) a telephone line breaks up or drops out; or</li> <li>b) there is a dispute arising out of the use of telephone lines in a Contest (including situations where multiple telephone lines are used); or</li> <li>c) two telephone lines are crossed during a phone in Contest;</li> </ul> <p>the Organiser may in its absolute discretion disqualify the relevant caller or callers for any reason whatsoever, and shall not be responsible for awarding a Prize to the relevant caller or callers, and may award the Prize to another person, at its sole and absolute discretion.</p> <p>In the event that a voice other than the caller's (or Contestant's) is heard on the phone line, the qualifying Contestant or Winner will be the first person on the phone line to speak.
