TERMS AND CONDITIONS**

**A.BASIC TERMS**

1.	<b>Organiser</b>	Astro Radio Sdn Bhd
2.	<b>Radio Station</b>	MIX
3.	<b>Name of Contest</b>	The Last Bit with Aishah, Rod and Prem
4.	<b>Brief Description of Contest/ Programme</b>	This is an on-air contest to giveaway a minimum of RM100 cash prize.
5.	<b>Brief mechanism of Contest</b>	<p>The first three (3) callers through after the cue to call will have to take turns to guess the end bit of a famous song played.</p> <p>If caller number 1 failed to guess it correctly within the specified period of time, then the contest will move on to caller number 2 and so on. The Contest would end when all three (3) callers failed to guess correctly or once a caller guessed the end bit correctly. The caller who guessed the end bit correctly wins.</p> <p>A cash prize of RM100 is allocated for every contest segment. There will be three (3) Contestants per contest segment which are the first three (3) callers through after the cue to call. If all three (3) Contestants failed to guess the end bit correctly, then the cash prize of RM100 will snowball to the next contest segment. For illustration purpose:</p> <p><i>1<sup>st</sup> January 2019 – All three (3) Contestants failed to guess the end bit correctly, cash prize of RM100 will snowball to the next contest segment</i></p> <p><i>2<sup>nd</sup> January 2019 – All three (3) Contestants failed to guess the end bit correctly, cash prize of RM100 from 13<sup>th</sup> August and another RM100 from 14<sup>th</sup> August will snowball to the next contest segment</i></p> <p><i>3<sup>rd</sup> January 2019 – Caller number 2 guessed correctly, caller number 2 wins RM300</i></p> <p><i>4<sup>th</sup> January 2019 – Caller number 1 guessed correctly, caller number 1 wins RM100</i></p>
6.	<b>Eligibility Criteria</b>	The Contest is open to all Malaysians who are aged 18 years old and above as at 1 <sup>st</sup> January 2019.

8.	<b>Age of Eligibility</b>	18 years old and above as at 1 <sup>st</sup> January 2019.
9.	<b>Charges</b>	Standard telecommunication charges apply.
10.	<b>Contest Period</b>	1 <sup>st</sup> January – 31 <sup>st</sup> December 2019.
11.	<b>Language of Contest</b>	English
12.	<b>Entry Procedure</b>	The first three (3) callers through after the cue to call on +603 9543 3322

16.	<b>Selection of Winners</b>	The first three (3) callers through after the cue to call will take turns to guess the end bit of a famous song played within the specified period of time and the caller who guessed the end bit correctly wins.
17.	<b>Prize</b>	Minimum of RM100 cash prize, depending on snowball amount
18.	<b>Notification of winners</b>	Winners will be notified by the Organiser.

21.	<b>Additional Terms, if any</b>	<p>LINE DROP OUT AND INABILITY TO CONTACT***</p> <p>Telephone Contests No liability is assumed by the Organiser for faulty, mistranscribed, misdirected/misdialled telephone communication or technical difficulties experienced by callers throughout the call-in portion of a Contest.</p> <p>If in the course of a Contest -</p> <ol style="list-style-type: none"> <li>a telephone line breaks up or drops out; or</li> <li>there is a dispute arising out of the use of telephone lines in a Contest (including situations where multiple telephone lines are used); or</li> <li>two telephone lines are crossed during a phone in Contest;</li> </ol> <p>The Organiser may in its absolute discretion disqualify the relevant caller or callers for any reason whatsoever, and shall not be responsible for awarding a Prize to the relevant caller or callers, and may award the Prize to another person, at its sole and absolute discretion.</p> <p>In the event that a voice other than the caller's (or Contestant's) is heard on the phone line, the qualifying Contestant or Winner will be the first person on the phone line to speak. If the judge(s) is not able to determine which caller was the first to speak on the phone line, a random drawing will be held to determine the Winner, and the outcome of the draw will be final.</p> <p>Any entries which are found to have used telephone switching or programming equipment shall be disqualified.</p> <p>In telephone Contests, "sonic triggers" are effective only when heard on on-air radio broadcast, and internet streaming shall not be valid as there may be delays in audio transmission or errors on the internet</p> <p>In the event the telegraphic transfer transaction to the Winner's</p>

		<p>bank account fails due to incomplete and/or wrong information provided by the Winner, the Organiser reserves the right to deduct RM10.00 from the value of the Prize for each re-submission of such transaction.</p> <p>In the event the Winner requires reissuance of cheque for the Prize, RM50.00 will be deducted from the value of the Prize unless such reissuance is due to the negligence, omission and/or fault of the Organiser.</p> <p>Any decisions by the Organiser relating to the Contest shall be final and the Organiser will not entertain any appeals by the Contestants against the decision.</p>
