### A. BASIC TERMS

1.	<b>Organiser</b>	<b>ASTRO RADIO SDN BHD (COMPANY NO. 199601031120 (403472-D))</b>
2.	<b>Radio Station</b>	MY, HITZ FM, Mix FM, Lite FM, Melody, Goxuan, Raaga, MY Sabah, MY Sarawak, HITZ FM Sabah, HITZ FM Sarawak
3.	<b>Name of Contest</b>	SYOK 101 with SYOK
4.	<b>Brief Description of Contest/ Programme</b>	This is a call-in contest to win a minimum of RM100 cash.
5.	<b>Brief mechanism of Contest</b>	<ol style="list-style-type: none"> <li>1. Download the SYOK mobile application / update the existing SYOK mobile application.</li> <li>2. Be the first caller through after the cue to call.</li> <li>3. Answer a simple question correctly about SYOK to win a minimum of RM100 cash.</li> <li>4. If the answer is incorrect, the Contestant will not win any cash prize and the cash prize will be snowballed to the next contest segment.</li> </ol> <p>The Contestants must adhere to the mechanism of the Contest as may be changed, amended, notified or communicated by the Organiser during the Contest Period.</p>
6.	<b>Eligibility Criteria</b>	<ol style="list-style-type: none"> <li>a) The Contest is open to all Malaysians of the Age of Eligibility below.</li> <li>b) Contestants must be Malaysian citizens and must possess valid Malaysian Identity Cards.</li> </ol>
7.	<b>Ineligibility</b>	<p>The following persons are not eligible to participate in the Contest :-</p> <ol style="list-style-type: none"> <li>(a) Employees/vendors/contractors and their *immediate family members of the Organiser, MEASAT Broadcast Network Systems Sdn Bhd, Astro Entertainment Sdn Bhd, Astro Production Sdn Bhd, Astro Digital 5 Sdn Bhd and Astro Malaysia Holdings Berhad, the sponsor of the Contest and their affiliates and partners.</li> <li>(b) Has won any prize(s) up to a value either individually or collectively of a value of RM1,000 and below from the Radio Station in the period of thirty (30) days prior to entering the Contest.</li> <li>(c) Has won any prize(s) up to a value either individually or collectively of a value of RM1,001 to RM5,000 from the Radio Station in the period of ninety (90) days prior to entering the Contest.</li> <li>(d) Has won any prize(s) up to a value either individually or collectively of a value of RM5,001 and above from the Radio Station in the period of three hundred and sixty-five (365) days prior to entering the Contest.</li> </ol> <p>*immediate family members mean spouse, children, parents, brothers and sisters</p>

The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest. 		<p>In the event the winner requires reissuance of cheque for the Prize, RM50.00 will be deducted from the value of the Prize unless such reissuance is due to the negligence, omission and/or fault of the Organiser</p> <p><b>LINE DROP OUT AND INABILITY TO CONTACT***</b></p> <p>Telephone Contests No liability is assumed by the Organiser for faulty, mistranscribed, misdirected/misdialled telephone communication or technical difficulties experienced by callers throughout the call-in portion of a Contest.</p> <p>If in the course of a Contest -</p> <ol style="list-style-type: none"> <li>a) a telephone line breaks up or drops out; or</li> <li>b) there is a dispute arising out of the use of telephone lines in a Contest (including situations where multiple telephone lines are used); or</li> <li>c) two telephone lines are crossed during a phone in Contest;</li> </ol> <p>the Organiser may in its absolute discretion disqualify the relevant caller or callers for any reason whatsoever, and shall not be responsible for awarding a Prize to the relevant caller or callers, and may award the Prize to another person, at its sole and absolute discretion.</p> <p>In the event that a voice other than the caller's (or Contestant's) is heard on the phone line, the qualifying Contestant or Winner will be the first person on the phone line to speak. If the judge(s) is not able to determine which caller was the first to speak on the phone line, a random drawing will be held to determine the Winner, and the outcome of the draw will be final.</p> <p>Any entries which are found to have used telephone switching or programming equipment shall be disqualified.</p> <p>In telephone Contests, "sonic triggers" are effective only when heard on on-air radio broadcast, and internet streaming shall not be valid as there may be delays in audio transmission or errors on the internet</p> <p>All Prizes won are strictly non-transferable to another party and cannot be exchanged or re-sold in any manner whatsoever for any other item, prize or cash.</p> <p>The panel of judges (if applicable) will be determined at the sole discretion of the Organiser and/or the sponsor.
