1.	<b>Organiser</b>	Astro Radio Sdn Bhd
2.	<b>Radio Station</b>	MY
3.	<b>Name of Contest</b>	James Yang New Album Showcase entry tickets giveaway.
4.	<b>Brief Description of Contest/ Programme</b>	This is an online contest to give tickets to attend James Yang New Album Showcase.
5.	<b>Brief mechanism of Contest</b>	<p>The Contest will be promoted on air, online, social media and on-ground.</p> <p>Log on to my.com.my to take part in the contest by answering one simple question and complete a slogan.</p> <p>The participants who answer the question correctly and provide the slogan in the most creative way, as determined by the organiser in its sole and absolute discretion, will win 2 entry tickets to attend James Yang New Album Showcase and a karaoke voucher worth RM50.</p> <p>A Contestant may submit multiple entries in this Contest. However, a Contestant can only win once in this Contest.
