3.	Name of Contest	MY Typing Challenge Season 2
4.	Brief Description of Contest/ Programme	This is an online contest to find out who is the fastest in typing challenge.
5.	Brief mechanism of Contest	The Contest will be promoted on air, online and social media.
		The contestants must type the designated sentences correctly in the shortest time which announce via Facebook Live. The contest will only available according to the contest schedule as below:
		4 th March 2019, Monday: DJ Champion Challenge 02:30pm 6 th March 2019, Wednesday: Top 9 Recruitment 1, 09:30am 8 th March 2019, Friday: Top 9 Recruitment 2, 09:30am 11 th March 2019, Monday: Top 9 Recruitment 3, 09:30am 15 th March 2019, Friday: Top 10 Final, 09:30am
		The top 3 winners of each recruitment will enter the Top 10 Final round. The final winner will get a chance to win the title "WINNER OF MY TYPING CHALLENGE SEASON 2".
		Announcer will call out to the winner to answer a simple question, once the winner answer correctly will win the grand prize of 3 months supply of movie and concert tickets which collaborating with MY.

21.	Additional Terms, if any	All Prizes won are strictly non-transferable to another party and cannot be exchanged or re-sold in any manner whatsoever for any other item, prize or cash.
