3.	<b>Name of Contest</b>	MY Typing Challenge Season 2
4.	<b>Brief Description of Contest/ Programme</b>	This is an online contest to find out who is the fastest in typing challenge.
5.	<b>Brief mechanism of Contest</b>	<p>The Contest will be promoted on air, online and social media.</p> <p>The contestants must type the designated sentences correctly in the shortest time which announce via Facebook Live. The contest will only available according to the contest schedule as below:</p> <p>4<sup>th</sup> March 2019, Monday: DJ Champion Challenge 02:30pm 6<sup>th</sup> March 2019, Wednesday: Top 9 Recruitment 1, 09:30am 8<sup>th</sup> March 2019, Friday: Top 9 Recruitment 2, 09:30am 11<sup>th</sup> March 2019, Monday: Top 9 Recruitment 3, 09:30am 15<sup>th</sup> March 2019, Friday: Top 10 Final, 09:30am</p> <p>The top 3 winners of each recruitment will enter the Top 10 Final round. The final winner will get a chance to win the title "WINNER OF MY TYPING CHALLENGE SEASON 2".</p> <p>Announcer will call out to the winner to answer a simple question, once the winner answer correctly will win the grand prize of 3 months supply of movie and concert tickets which collaborating with MY.</p> <p>The Contestants must adhere to the mechanism of the Contest as may be changed, amended, notified or communicated by the Organiser during the Contest Period.</p>
