3.	Name of Contest	Ah Boys To Men 4 special screening passes giveaway.
4.	Brief Description of Contest/ Programme	This is an online contest to give away special screening passes to watch Ah Boys To Men 4.
5.	Brief mechanism of Contest	The Contest will be promoted on air, online, social media and on-ground. Log on to my.com.my to take part in the contest by answering one simple question and complete a slogan. The participants who answer the question correctly and provide the slogan in the most creative way, as determined by the organiser in its sole and absolute discretion, will win 2 movie special screening passes to watch Ah Boys To Men 4.
6.	Eligibility Criteria	The Contest is open to all Malaysians who are aged 13 years old and above as at 13th November 2017. Contestants under the age of 13 years old must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in this Contest and to receive the Prize.
