1.	<b>Organiser</b>	Astro Radio Sdn Bhd
2.	<b>Radio Station</b>	MY
3.	<b>Name of Contest</b>	Fall in Love at First Kiss movie preview passes giveaway.
4.	<b>Brief Description of Contest/ Programme</b>	This is a call-in contest and online contest to give away Fall in Love at First Kiss movie preview tickets.
