1.	<b>Organiser</b>	Astro Radio Sdn Bhd
2.	<b>Radio Station</b>	MY
3.	<b>Name of Contest</b>	L Storm movie preview passes giveaway.
4.	<b>Brief Description of Contest/ Programme</b>	This is a call-in contest and online contest to give away L Storm movie preview tickets.
5.	<b>Brief mechanism of Contest</b>	<p>The Contest will be promoted on air, online and social media.</p> <p>The first caller through will be required to continue the dialogue after announcers play the snippet, in order to win 4 preview tickets to watch the movie.</p> <p>Besides that, listeners can log on to my.com.my to take part in the contest by answering one simple question and complete a slogan, in order to win 2 preview tickets to watch the movie.</p>
6.	<b>Eligibility Criteria</b>	<p>The Contest is open to all Malaysians who are aged 18 years old and above as at 11<sup>th</sup> August 2018.</p> <p>Contestants under the age of 18 years old must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in this Contest and to receive the Prize.</p> <p>The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest.</p> <p>The parents and/or guardian may at the absolute discretion of the Organiser be required to sign an indemnity in the form required by the Organiser as a precondition to their child's entitlement to the Prize(s).</p>

11.	<b>Language of Contest</b>	Cantonese or Mandarin
12.	<b>Entry Procedure</b>	Contestants need to listen to cue to call and provide his/her name, NRIC, telephone number before he/she can proceed to participate. Contestants must also agree with the Terms and Conditions of this contest before they participate in this contest
13.	<b>Entry Deadline</b>	Call in contest – 17 <sup>th</sup> August 2018 Online contest – 17 <sup>th</sup> August 2018, 12pm

16.	<b>Selection of Winners</b>	For call in contest, listeners need to continue the dialogue after announcers play the snippet.  For online contest, winners will be selected based on the most creative way in answering the question.
17.	<b>Prize</b>	For call in contest, winners will be rewarded with 4 L Storm preview tickets.  For online contest, winners will be rewarded with 2 L Storm preview tickets.
18.	<b>Notification of winners</b>	For call in contest, winners will be informed right after the contest segment.  For online contest, winners will be informed via SMS or call.
19.	<b>Collection Period</b>	During the movie preview on 20 <sup>th</sup> August 2018, between 8.30pm to 9pm (movie screening starts at 9pm). The collection details will be informed when organizer announces the winner.
20.	<b>Collection Venue</b>	During the movie preview at GSC Pavilion KL. The collection details will be informed when organizer announces the winner.
21.	<b>Additional Terms, if any</b>	<p>LINE DROP OUT AND INABILITY TO CONTACT</p> <p>Telephone Contests No liability is assumed by the Organiser for faulty, mistranscribed, misdirected/misdialled telephone communication or technical difficulties experienced by callers throughout the call-in portion of a Contest.</p> <p>If in the course of a Contest :-</p> <ul style="list-style-type: none"> <li>a) a telephone line breaks up or drops out; or</li> <li>b) there is a dispute arising out of the use of telephone lines in a Contest (including situations where multiple telephone lines are used); or</li> <li>c) two telephone lines are crossed during a phone in Contest;</li> </ul> <p>the Organiser may in its absolute discretion disqualify the relevant caller or callers, and shall not be responsible for awarding a Prize to the relevant caller or callers, and may award the Prize to another person according to its absolute discretion.</p> <p>In the event that more than one voice is heard on the phone line, the qualifying Contestant or Winner will be the first person to</p>

If the judge(s) is not able to determine which caller was first, a random drawing will be held to determine the Winner.</p> <p>Any entries which are found to have used telephone switching or programming equipment shall be disqualified.</p> <p>In telephone Contests, "sonic triggers" are effective only when heard on on-air radio broadcast, and internet streaming shall not be valid as there may be delays in audio transmission or errors on the internet.</p>
