

MY FM WHAT ARE YOU SAYING? (WEEK 1) TERMS AND CONDITIONS

A. BASIC TERMS

1.	Organiser	Astro Radio Sdn Bhd
2.	Radio Station	MY FM
3.	Name of Contest	MY FM What Are You Saying? (in Mandarin: MY FM 咕噜咕噜 BABABA)
4.	Brief Description of Contest/ Programme	This is a call-in contest to give away cash prize.
5.	Brief mechanism of Contest	The contest will be promoted on-air, online and on social media.
		MY FM Facebook will post a video of artistes or announcers saying a sentence while putting on a lip restrainer.
		The first caller through will be required to guess the correct sentence to win RM1,000 cash prize. The correct answer will be revealed after the last contest segment of the day. RM1,000 cash prize will be allocated among the winners who can provide the correct answer. For example, there are 5 contest segments in a day, if there are five winners who are able to provide the correct answer, each of them will be rewarded with RM200 cash prize. If there is no winner on that particular contest day, RM1,000 cash prize will be snowball to the following day.
6.	Eligibility Criteria	The Contest is open to all Malaysians who are aged 18 years old and above as at 3 rd July 2017.
		Contestants under the age of 18 years old must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in this Contest and to receive the Prize. The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest.
		The parents and/or guardian may at the absolute discretion of the Organiser be required to sign an indemnity in the form required by the Organiser as a precondition to their child's entitlement to the Prize(s).
