(A) Registration

(B) Day 1 Audition (Open)

The Day 1 Audition at each Address comprises the following rounds:

- (a) Round 1 Registered Contestants will be given Radio and TV scripts to present as a radio announcer and TV host respectively (1 minute/script); and
- (b) Round 2 Registered Contestants are required to showcase their talent (singing, dancing, playing music instrument, mimicry, etc.) (1 minute).

Top Ten (10) Registered Contestants with the highest cumulative score from judges based on showmanship, creativity, sound quality and clarity, and stage presence will *move to* Day 2 audition at the relevant Address ("Shortlisted Contestants").

In the event of a tie, the relevant Registered Contestants with the tie-score will be invited as Shortlisted Contestants for Day 2 Audition.

The shortlisting shall be at the judges' sole discretion whose decision shall be final and no appeals shall be entertained.

(C) Day 2 Audition (Open)

The Day 2 Audition at each Address comprises the following rounds:

- (a) Round 1: Shortlisted Contestants will be asked about themselves and some general knowledge questions to test out their knowledge and thinking abilities (1 minute); and
- (b) Round 2: Shortlisted Contestants will be given a Radio/TV situation/Digital scenario on set or studio. Based on the scenario given, Shortlisted Contestants will need to host the show accordingly (3 minutes).

Top three (3) Shortlisted Contestants with the highest cumulative score from judges based on showmanship, creativity, sound quality and clarity, and stage presence will move to the Finale ("Finalists").

In the event of a tie, the relevant Shortlisted Contestants with the tie-score will be tested via a bonus round consisting of a speech for 1 minute. Such Shortlisted Contestant succeeds in the bonus round will be invited as Finalist for the Finale.

The shortlisting shall be at the judges' sole discretion whose decision shall be final and no appeals shall be entertained.

Only three (3) Finalists with the highest cumulative score from judges will move to Round 3 ("Round 3 Finalists"). (c) Round 3 – Co-Host Round: Round 3 Finalists will be pairing up with a co-host (existing host) to host the Finale showcase. Judges will score the Round 3 Finalists based on the showmanship, creativity, sound quality and clarity, and stage presence and two (2) Round 3 Finalists with the highest cumulative score from judges will move to the Round 4 ("Round 4 Finalists"). (d) Round 4 – Final Round: Round 4 Finalists will be given a surprise scenario to host. Judges will score the Round 4 Finalists based on the showmanship, creativity, sound quality and clarity, and stage presence. The Round 4 Finalist with the highest cumulative score from judges will be the Winner of the Gameshow subject always to the acceptance of conditions set out in Clause 16 below. In the event of a tie in any of Round 2, Round 3 or Round 4, the relevant Finalist in Round 2, Round 3 Finalist or Round 4 Finalist with the tie-score will be tested via a bonus round consisting of a speech for 1 minute.
