### A. BASIC TERMS

1.	<b>Organiser</b>	<b>ASTRO RADIO SDN BHD</b>
2.	<b>Radio Station</b>	RAAGA
3.	<b>Name of Contest</b>	Raagavil Dhillu Iruntha Kaasu
4.	<b>Brief Description of Contest/ Programme</b>	This is a call-in contest. It is a Song based contest where participant need to guess the missing word in the song correctly. If the guess is correct they will get the chance to walk away with cash or double it for the next round. 3 rounds in total. Whichever round you lose, you will walk away with no cash prize at all.
5.	<b>Brief mechanism of Contest</b>	Insert brief mechanism of Contest e.g. <ol style="list-style-type: none"> <li>1. Be the first caller through after the cue to call;</li> <li>2. Guess the missing word from the song snippet correctly to win RM50.</li> <li>3. Participant will get a chance to decide whether to just win RM50 or they want to double it.</li> <li>4. If participant choose to double it, they will go through the second round which is to guess the missing word from another song snippet, if they manage to answer correctly, they will win RM 100</li> <li>5. Participant will be asked to win it or double it again for the third round, if listener choose to double it, they will go for 3<sup>rd</sup> round and will need to guess the missing word from another song snippet, and if they manage to answer it correctly, the listener will win a total of RM200!</li> <li>6. Whichever round he/she loses, the listener wins nothing.</li> <li>7. Participants need to guess the missing word in 10 seconds for all the 3 rounds.</li> </ol> <p>The Contestants must adhere to the mechanism of the Contest as may be changed, amended, notified or communicated by the Organiser during the Contest Period.</p>
8.	<b>Eligibility Criteria</b>	<ol style="list-style-type: none"> <li>a) The Contest is open to all Malaysians of the Age of Eligibility below.</li> <li>b) Contestants must be Malaysian citizens and must possess valid Malaysian Identity Cards.</li> </ol>
9.	<b>Ineligibility</b>	<p>The following persons are not eligible to participate in the Contest :-</p> <ol style="list-style-type: none"> <li>(a) Employees/vendors/contractors and their *immediate family members of the Organiser, MEASAT Broadcast Network Systems Sdn Bhd, Astro Entertainment Sdn Bhd, Astro Production Sdn Bhd, Astro Digital 5 Sdn Bhd and Astro Malaysia Holdings Berhad, the sponsor of the Contest and their affiliates and partners.</li> <li>(b) Has won any prize(s) up to a value either individually or collectively of a value of RM1,000 and below from the Radio Station in the period of thirty (30) days prior to entering the Contest.</li> <li>(c) Has won any prize(s) up to a value either individually or collectively of a value of RM1,001 to RM5,000 from the Radio Station in the period of ninety (90) days prior to entering the Contest.</li> <li>(d) Has won any prize(s) up to a value either individually or collectively of a value of RM5,001 and above from the Radio Station in the</li> </ol>

1	<b>Age of Eligibility</b>	<p>c) The Contest is open to all Malaysians who are 18 years old and above as at 11<sup>th</sup> March 2019</p> <p>d) Where the Age of Eligibility permits participation of Contestants under the age of 18 years old, the Contestant must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in the Contest and to receive the Prize. The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest. The parents and/or guardian may at the absolute discretion of the Organiser be required to sign an indemnity in the form required by the Organiser as a precondition to their child's entitlement to the Prize.</p>

1	<b>Entry Procedure</b>	The Contestant must be the first caller through after the cue to call.

1	<b>Mode</b>	Call-In – By calling Radio Station's telephone number - 03-95430993

1	<b>Selection of winners</b>	The first caller through after the cue to call, identify the missing word from the song snippet played by the announcer correctly within ten (10) seconds.
1	<b>Prize</b>	<p>RM 50 – first round</p> <p>RM100 – second round</p> <p>RM200 – Third round</p>
2	<b>Notification of winners</b>	Winners will be notified right after the call-in Contest.
2	<b>Collection Period</b>	Telegraphic Transfer to the winner's bank account within 1 month from notification by the Organiser
2	<b>Collection Venue</b>	Not applicable
2	<b>Additional Terms, if any</b>	<p>In the event the telegraphic transfer transaction to the winner's bank account fails due to incomplete and/or wrong information provided by the winner, the Organiser reserves the right to deduct RM10.00 from the value of the Prize for each re-submission of such transaction.</p> <p>In the event the winner requires reissuance of cheque for the Prize, RM50.00 will be deducted from the value of the Prize unless such reissuance is due to the negligence, omission and/or fault of the Organiser.</p> <p>LINE DROP OUT AND INABILITY TO CONTACT***</p> <p>Telephone Contests No liability is assumed by the Organiser for faulty, mistranscribed, misdirected/misdialled telephone communication or technical difficulties experienced by callers throughout the call-in portion of a Contest.</p>

		<p>If in the course of a Contest -</p> <ul style="list-style-type: none"> <li>a) a telephone line breaks up or drops out; or</li> <li>b) there is a dispute arising out of the use of telephone lines in a Contest (including situations where multiple telephone lines are used); or</li> <li>c) two telephone lines are crossed during a phone in Contest;</li> </ul> <p>the Organiser may in its absolute discretion disqualify the relevant caller or callers for any reason whatsoever, and shall not be responsible for awarding a Prize to the relevant caller or callers, and may award the Prize to another person, at its sole and absolute discretion.</p> <p>In the event that a voice other than the caller's (or Contestant's) is heard on the phone line, the qualifying Contestant or Winner will be the first person on the phone line to speak. If the judge(s) is not able to determine which caller was the first to speak on the phone line, a random drawing will be held to determine the Winner, and the outcome of the draw will be final.</p> <p>Any entries which are found to have used telephone switching or programming equipment shall be disqualified.</p> <p>In telephone Contests, "sonic triggers" are effective only when heard on on-air radio broadcast, and internet streaming shall not be valid as there may be delays in audio transmission or errors on the internet</p> <p>All Prizes won are strictly non-transferable to another party and cannot be exchanged or re-sold in any manner whatsoever for any other item, prize or cash.</p> <p>The panel of judges (if applicable) will be determined at the sole discretion of the Organiser and/or the sponsor. The Organiser may in its absolute discretion disqualify any Contestants for any reason whatsoever, and any decisions by the judges, Organiser and/or the sponsor relating to the Contest shall be final and the Organiser and/or the sponsor will not entertain any appeals by the Contestants against the decision.</p> <p>If the Prizes awarded by the Organiser are in the form of free tickets or passes:</p> <ul style="list-style-type: none"> <li>(a) the winner shall be bound by the event promoter's or sponsor's terms and conditions;</li> <li>(b) the winner must adhere to those terms and conditions set out on the ticket (such as film classification) and the rules and regulations of the venue thereof; and</li> <li>(c) the venue, date and time of the event/programme/movie/show may be changed at any time at the absolute discretion of the Organiser, event promoter or sponsor.</li> </ul>
