#### A. BASIC TERMS

1.	<b>Organiser</b>	Astro Radio Sdn Bhd
2.	<b>Radio Station</b>	Raaga
3.	<b>Name of Contest</b>	#RaagaBaby
4.	<b>Brief Description of Contest/ Programme</b>	Announcers will be asking listeners to join our contest by taking videos of kids dancing and posting in Instagram with #Raagababy <b>on their respective</b> accounts. Listeners shall stand a chance to win RM50.
5.	<b>Brief mechanism of Contest</b>	<b>The mechanics:</b> <ul style="list-style-type: none"><li>• Contest will take place between 11<sup>th</sup> March – 15<sup>th</sup> March 2019, Monday to Friday.</li><li>• The theme of the video should be dancing.</li><li>• Videos incorporating the theme (dancing) can be uploaded throughout the day with #RaagaBaby</li><li>• The station will select an entry (the selection time shall be at the announcers' discretion);</li><li>• The announcers shall provide certain descriptive clues of the selected entry and the Listeners will be required to call into the station;</li><li>• Based on the descriptive clues provided by the announcer, to the event Listener feels that his/her selfie has been selected, the Listener shall need to call into the station within a stipulated time (as announced by the announcer);</li><li>• If the Listener correctly calls in to his/her entry, the Listener shall be able to win cash prize of RM50.</li><li>• If there's no winner for a selection slot, there will be no snowball.</li></ul>
