3.	<b>Brief Description of Contest/ Programme</b>	This is an online contest for a chance to win a share of RM30,000 in cash.

Log on to SYOK website <a href="https://syok.my/">https://syok.my/</a> or SYOK mobile application and join the SYOK Live Session.</li> <li>2. Participants need to answer ONE (1) question correctly in the fastest time at the comment section during the Live session.</li> <li>3. 6 Winners will be chosen in each round based on the moderator's screen.</li> <li>4. There will be 10 rounds throughout the day.</li> <li>5. Each winner will win RM500 cash prize.</li> </ol> <p>A Contestant may submit multiple entries in this Contest. However, a Contestant can only win once in this Contest.
