## A. BASIC TERMS

1.	Organiser	ASTRO RADIO SDN BHD (COMPANY NO. 199601031120 (403472-D))

3.	Name of Competition/ Programme	Jodi@RAAGA
4.	Brief Description of Competition	Jodi@RAAGA is a competition organized by the Organiser to search for talent whereby the Winners will win cash prizes.
5.	Brief mechanism of Competition	<ul> <li>Contestants are required to upload a one (1) minute video of them performing in a pair (singing, dancing, acting, doing standup comedy or any other special talent) on Instagram with hashtag #jodiatraaga and tag @raaga.my in the caption.</li> <li>The song chosen by the Contestants must be one of the songs listed on raaga.my.</li> <li>The performances must be original and must not be a copy/reenactment of an existing performance (for example, an existing dance performance or film scenario etc.).</li> <li>Contestants should not be an existing artist under any recording label and/or must not have previously released any songs.</li> <li>The video must not have any sort of filter or video effects, and must not utilize any other filters or features available from other social media platforms (such as TikTok or SnapChat).</li> <li>Contestants are required to keep their Instagram profile / account / post public during the Competition Period.</li> <li>Contestants can submit more than one (1) entry but only one (1) entry will be chosen for review by the Organiser.</li> </ul>

(Voting period: 22<sup>nd</sup> February 2021 to 26<sup>th</sup> February 2021).</li> <li>Round 3: Grand Finale Week (1<sup>st</sup> March 2021 – 7<sup>th</sup> March 2021)</li> <li>Top five (5) pair of Contestants with highest votes received during Round 2, will enter another round of voting on raaga.my (Voting period: 1<sup>st</sup> March 2021 – 7<sup>th</sup> March 2021)</li> <li>They will also take part in a final round that will be premiered on 6th March 2021 at RAAGA Facebook page.</li> <li>Any Contestants who fail to participate in the finale event will be automatically eliminated.</li> <li>Winner Announcement (8<sup>th</sup> March 2021)</li> <li>Three (3) pairs of Contestants with the highest number of votes and marks from the panel of judges will be announced as the Winners to win the cash prize in Kalakkal Kaalai on 8<sup>th</sup> March 2021.</li> </ul>

6.	Eligibility Criteria	a) The Competition is open to all Malaysians of the Age of Eligibility below.
		b) Contestants must be Malaysian citizens and must possess valid Malaysian Identity Cards.

		(b) Has won any prize(s) up to a value either individually or collectively of a value of RM1,000 and below from the Radio Station in the period of thirty (30) days prior to entering the Competition.
