



## SPIN TO WIN ON SYOK TERMS AND CONDITIONS

### A. BASIC TERMS

1.	<b>Organiser</b>	ASTRO RADIO SDN BHD (COMPANY NO. 199601031120 (403472-D))
2.	<b>Name of Contest</b>	SYOK Spin To Win
3.	<b>Brief Description of Contest/ Programme</b>	This is an online contest available on the SYOK app which will be held in conjunction/ in connection with various campaigns as determined by the Organiser (“ <b>Campaign</b> ”). Contestants will have the opportunity to win a range of prizes by answering three (3) questions correctly, which would entitle the contestants to spin the wheel and win a prize.
4.	<b>Brief mechanism of Contest</b>	<ol style="list-style-type: none"> <li>1. This contest is only available on the SYOK app and contestants are required to download the SYOK app from the Apple store (IOS), Google Play Store (Android) or Huawei App Gallery (for Huawei users only). Users who access SYOK via the website will be redirected to download the app in order to participate in this contest;</li> <li>2. Launch the SYOK app;</li> <li>3. Go to the 'PLAY' tab;</li> <li>4. Click on 'SYOK Spin To Win';</li> <li>5. Contestants are required to answer three (3) questions (multiple choice) correctly to be entitled to spin the wheel;</li> <li>6. Contestants will then be prompted to spin the wheel;</li> <li>7. After spinning the wheel, the Contestants will need to key in their details and click submit in order to claim the prize;</li> <li>8. Each Contestant will only be able to spin the wheel twice per day, on the condition that they have answered all six (6) questions correctly (i.e. three (3) questions for each spin the wheel attempt).</li> <li>9. Each Contestant will also only be able to win a maximum of two (2) times during the Contest Period.</li> </ol> <p>The Contestants must adhere to the mechanism of the Contest as may be changed, amended, notified or communicated by the Organiser during the Contest Period.</p>
5.	<b>Eligibility Criteria</b>	<ol style="list-style-type: none"> <li>a) The Contest is open to all Malaysians of the Age of Eligibility below.</li> <li>b) Contestants must be Malaysian citizens and must possess valid Malaysian Identity Cards.</li> </ol>
6.	<b>Ineligibility</b>	<p>The following persons are not eligible to participate in the Contest:</p> <ol style="list-style-type: none"> <li>(a) Employees/vendors/contractors and their *immediate family members of the Organiser, MEASAT Broadcast Network Systems Sdn Bhd, Astro Entertainment Sdn Bhd, Astro Production Sdn Bhd, Astro Digital 5 Sdn Bhd and Astro Malaysia Holdings Berhad, the sponsor of the Contest and their affiliates and partners.</li> </ol> <p>*immediate family members mean spouse, children, parents, brothers and sisters</p>
7.	<b>Age of Eligibility</b>	<ol style="list-style-type: none"> <li>a) The Contest is open to all Malaysians who are 18 years old and above at the time of submission of entry or as at the date of participation in the Contest.</li> </ol>

		b) Where the Age of Eligibility permits participation of Contestants under the age of 18 years old, the Contestant must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in the Contest and to receive the Prize. The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest. The parents and/or guardian may at the absolute discretion of the Organiser be required to sign an indemnity in the form required by the Organiser as a precondition to their child's entitlement to the Prize.

11.	<b>Entry Procedure</b>	The Contestant must launch the SYOK mobile application, follow the instructions, answer the questions and fill in all the details required.
12.	<b>Entry Deadline</b>	14 <sup>th</sup> August 2022
13.	<b>Mode</b>	Online - SYOK mobile application only
14.	<b>Address</b>	All Asia Broadcast Centre, Technology Park Malaysia, Lebuhraya Puchong-Sungai Besi, Bukit Jalil, 57000 Kuala Lumpur
15.	<b>Selection of winners</b>	Contestants must first answer all three questions given correctly in order to be eligible to spin the wheel and claim one (1) prize upon a successful spin. Contestants are entitled to claim/ win two (2) prizes throughout the Contest Period.
16.	<b>Prize</b>	The spin the wheel prizes will be as determined by the Organiser from time to time, in its absolute discretion. Please refer to the contest and/or Campaign details on the SYOK mobile application.
